Reya Raihan is authorized to leave Bangladesh and remain in Nepal from 05 August 2026 to 09 August 2026.

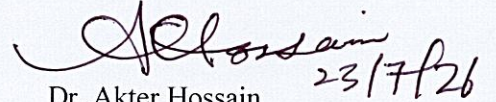
II. Terms and Conditions for Official Visit

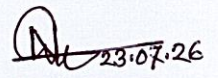
